There were even speculations that most of the election results were pre- allocated as most of the result that were eventually uploaded at the portal were dated 20th of February far even before the elections were conducted on the 25th of February. It was really an exercise with full manipulations and discrepancies in the final results.

Whatever it is the elections have been concluded and Bola Tinubu of the All Progressive Congress have been declared winner by the Returning officer, Prof. Mahmoud Yakubu the Chairman of INEC. It therefore behooves on other candidates who believed that the elections were rigged in favour of the ruling Party to take their matter to the Supreme Court to challenge the INEC declaration.
